2.4 What are the headline aims of the proposal and the objectives that will help to accomplish these aims? (Max 250 words)

The Low-Income Family Tracker (LIFT) is a platform that layers multiple datasets held within the Council, alongside some external datasets, and applies modelling to provide insights down to a household level.

There are two main ways to use LIFT: the first is to model a family's circumstances and filter them to implement targeted support measures; the second is to increase benefits take up across the district. The benefits data we hold will be able to tell us a family's income, and LIFT will be able to model their outgoings based on age, family size, and housing tenure etc. From this, it will be possible to model which families may be in a cash surplus or shortfall each month, and target support at those households which are in a cash shortfall but not necessarily presenting as in debt to the Council. For the benefits take-up side of LIFT, as we will know a household's income and what benefits they are claiming, we will be able to see which households are eligible for certain benefits but are not claiming this. We will then be able to contact these residents directly, let them know how much extra they could be claiming each month, and support them to apply for these unclaimed benefits.

Some service users will be contacted proactively to be offered existing support. This could result in an increase in their income and have a positive impact on their circumstances. They could also avoid evictions and debt by being supported with early intervention methods from the Council. It will also allow us to see which residents should be claiming certain benefits but are, which could result in a material increase in their income once they start to claim this.

The first phase of the cost of living support programme identified a clear need for a more coordinated and data driven approach to the support we give. Due to the rural nature of the district, targeting support was extremely difficult. As



we hold lots of data on residents already, it became clear that we needed to find a way to utilise this effectively, hence the investment in LIFT. Additionally, Policy in Practice recently released research outlining that there is over £23 billion worth of unclaimed benefits in the UK each year. That research is here:

Details: There will be a positive impact on those affected by the project. This is because they will be offered further support in a more proactive manner. The project could also identify that they should be claiming certain benefits but aren't which they might not be aware of. Further support will be offered to apply for these.

⊠Age



Details: There will be a positive impact on people of all ages. Older people will likely be one of the main target groups for additional support, particular with the pension credits benefits take up campaign. It is estimated that around 10% of people aged over 66 experience frailty (Turner, 2014), meaning that they are more at risk of negative health outcomes due to poor health. It is therefore essential to target support at these individuals to save money across the system and provide a more compassionate response.

⊠Disability

Details: There will be a positive impact on people with disabilities, as they will be offered further support. They will likely be one of the main target groups to support, and supported to access existing services, as they are more disproportionately affected by cost of living pressures. Research has previously shown that disabled people spend on average £583 a month in extra costs associated with their disabilities (Scope, 2024). As inflation has increased, the absolute cost increase they experience has been much higher than those without disabilities as a result of this.

⊠Gender reassignment

Details: These will not be targeted directly but could feel the effect of any additional support.

⊠Marriage and Civil Partnership

Details: These will not be targeted directly but could feel the effect of any additional support.

⊠Pregnancy and maternity

Details: These will not be targeted directly but could feel the effect of any additional support. Similarly, there is various additional support aimed at pregnant people and new parents, such as Healthy Start vouchers, that would be able to be promoted using LIFT.

⊠Race

Details: These will not be targeted directly but could feel the effect of any additional support. For example, people from Bangladeshi and Pakistani ethnic groups are around twice as likely to be in the bottom fifth of incomes than average, and have the



lowest median household incomes, closely followed by people from a Black ethnic group (<u>Francis-Devine</u>, 2020). These groups will likely benefit more from the LIFT project.

⊠Religion and belief

Details: These will not be targeted directly but could feel the effect of any additional support.

⊠Sex

Details: These will not be targeted directly but could feel the effect of any additional support. For example, single women are at highest risk of poverty (Women's Budget Group, 2020), and so will likely benefit from this project.

The project will be overseen by the LIFT Development Officer and constantly evaluated. Different families will be affected in different ways, as not every family will be eligible for every scheme. There will however be no negative impact on any family, with the worst outcome from this project being that a family continues as they are. Data for each project will be analysed throughout, with a full analysis taken following the conclusion of each project.
