## Referendum on the West Wickham Neighbourhood Plan

A referendum on the 'making' (adoption) of the West Wickham Neighbourhood Plan will be held on **Thursday 11 August 2022** at **West Wickham Village Hall, High Street, West Wickham, CB21 4SB**.

The question that will be asked in the referendum is: **“Do you want South Cambridgeshire District Council to use the neighbourhood plan for West Wickham to help it decide planning applications in the neighbourhood area?”**

The referendum area is identified on the map in figure 1 included at the end of this Information Statement. The referendum area is identical to the neighbourhood area designated in November 2015 for the West Wickham Neighbourhood Plan.

A person is entitled to vote in the referendum if on 11 August 2022:

- he or she is registered and entitled to vote in local council elections;
- he or she is over 18 years old; and
- his or her qualifying address is in the referendum area (shown at figure 1).

The referendum expenses limit that will apply in relation to the referendum is **£2,382.71**. This figure has been calculated based on the electorate for the specified neighbourhood area as at 1 December 2021.

The referendum will be conducted in accordance with procedures which are similar to those used at local government elections.

- the written representations on the submission version of the West Wickham Neighbourhood Plan, that were submitted to the independent examiner
- South Cambridgeshire District Council's decision statement on the receipt of the Examiner's Report and its decision to proceed to referendum, including a statement of satisfaction that the 'Referendum' version of the Neighbourhood Plan meets the Basic Conditions and is legally compliant; and

- a statement that sets out general information as to town and country planning including neighbourhood planning and the referendum.
